### SHELF LIFE

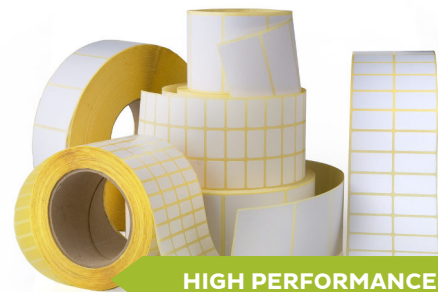
Can be stored 180 days in a clean dry place, in its original package at an average temperature of 25°C or below. Storage temperature should not exceed 40°C.
