RenLease[®] 79-2 is a semi-permanent, dry-film release agent that does not contain wax or silicone. Because the release agent does not transfer from the mold to the part, there is no effect on post-decoration of the part. RenLease[®] 79-2 is particularly effective on epoxies, polyurethane and polyester resins.

RenLease[®] 79-2 is based on fluorocarbon polymers (Teflon).

APPLICATION :

Apply RenLease[®] 79-2 to only clean, non-porous surfaces. Porous surfaces such as plaster and wood should be sealed with Ren[®] 802 or a good, clear lacquer before (204°C).

- Shake well before using and during use.
- Hold can 8 to 10 inches from surface.
- Apply a light, uniform coating. (If too much RenLease[®] 79-2 is applied, the surface will appear white.) Make sure the spray wets the entire surface.
- Clean valve after use, turn can upside down and spray 2-4 seconds.

SHELF LIFE :

Provided material is stored under dry conditions in their original containers, they will remain useable for two years from date of shipping.

Do not use or handle this product until the Material Safety Data Sheet has been read and understood.
